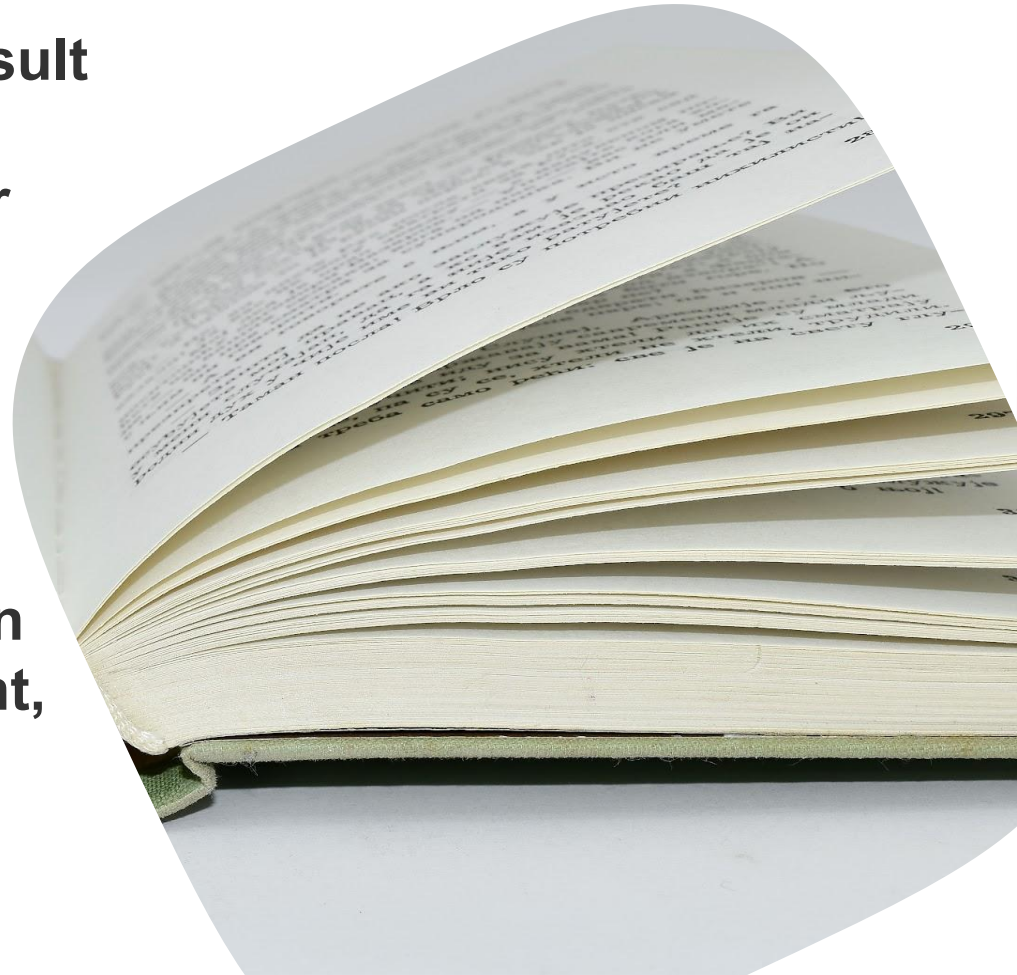

PEIMS Discipline Reporting 101

“Disciplinary actions that result in the removal of a student from any part of their regular academic program will be reported as: In-School Suspension (ISS), Out-of-School Suspension (OSS), Expulsion, Juvenile Justice Alternative Education Program (JJAEP) assignment, or DAEP assignment.”





Discipline Reporting Basics

- Discipline is reported to TEA in the Summer PEIMS Submission
- Districts only report Discipline to TEA if the student received ISS, OSS, DAEP or JJAEP (student taken out of the educational setting)
- LEA's must report what happens - even if it is incorrect
 - Example: OSS for homeless, OSS under grade 3, OSS/ISS more than 3 days
- TEA updated the TWEDS for further clarification of the limit of "suspension"
 - Now ISS can only be assigned/served for 3 days per incident
- Not only does discipline affect the PEIMS Submission via Fatals/Specials/Warnings, Discipline can also trigger Discipline Data Validations (DDV)
