

The Who, Why, and How...



- PEIMS is the vehicle we use to report discipline data to the Texas Education Agency (TEA).
- Texas Education Code (TEC) Chapter 37 – DISCIPLINE – **Defines legal procedures**
 - Training must be conducted every 3 years for campus/district administrators

The Who, Why, and How...

- We Report Discipline in our **SUMMER PEIMS SUBMISSION** to TEA in June.



- Discipline coding **DOES** affect state and federal accountability.

“Disciplinary actions that result in the removal of a student from any part of their regular academic program will be reported as: In-School Suspension (ISS), Out-of-School Suspension (OSS), Expulsion, Juvenile Justice Alternative Education Program (JJAEP) assignment, or DAEP assignment.”

Ed-Fi Data Loads



Now that Texas has switched from sending XML files to TEA for Summer Submission, to an API data load, be sure that your SIS is loading data into TEA's IODS for your district for summer data for 2025-2026. (Summer Promotion to TEA will open on February 23, 2026)

If the summer data is not transmitting, then discipline data will not show up in OnDataSuite for the 2025-2026 school year.

Don't forget... a new Key & Secret is needed for each school year!



When this happens, I check a few things in our SIS, first. Double check that the grade level is correct. Then I check attendance. If all looks right, contact Admin and re-teach this rule. **MUST REPORT WHAT OCCURRED.** If OSS was assigned and served - it stays a Special Warning.

If you look at your report, you can generate a CSV file to share with campus staff, if needed.



When I start researching my students/incident from this report, most are:

1. Elementary students who were put in ISS or OSS after their official attendance time
2. Secondary students who have a partial day ISS or partial day OSS so the official attendance time they show as present, therefore, there is no attendance like an absence for that student/incident.




